2. the MOTION of Danni Toscano, seconded by Lisa Knox, that a CT or HT rider must submit any two HT or CT scores, where they completed the course without being eliminated, to be eligible for the Championship Show;

3. the MOTION of Aneesa Romans, seconded by Sara Gartland, that all dressage Championship classes will be divided into Open, Adult Amateur, and Junior; and that the Show will offer one CT class per level, and the scores received will count for both that class and the Championship Class; and

4. Western dressage classes will be offered.

Lisa Knox will check into the availability of a food concession truck for the Show and report back to the Board.

Doreen Garland will run the 2017 Recognized Show as Secretary and the show will be held at Dunmovin'.
