I agree to wear protective headgear with harness attached that meet (or exceed) standards currently imposed by the *United States Equestrian Federation Rules for Eventing*. (Helmets passing or surpassing the ASTM/SEI standards are strongly encouraged when jumping).

I understand that any equine activity, and in particular riding horses, is a high risk activity, and that my participation in this activity is wholly at my own risk. I understand that my participation involves all inherent risks associated with the dangers and conditions which are an integral part of equine activities, including, but not limited to, the propensity of equines to behave in ways which may result in injury, harm or even death to humans or other animals around or near them; the unpredictability of equine reaction to sounds, sudden movements, smells, and unfamiliar objects; persons or other animals; hazards related to surface and subsurface conditions; collisions with other equines or objects; and, the potential of a participant to act in a negligent or unskilled manner which may contribute to injury to the participant or others, including failing or inability to maintain control over the animal. By participating in this activity **I agree** to assume responsibility for those risks, and **I release** and agree to hold harmless the activity organizers, organizing committee, officials, the owners and management of KeaLani Farm and KeaLani Farm LLC, their officers, agents, employees, any trainers, clinicians, other participants and the volunteers assisting in the conduct of this activity, from all liability for gross negligence resulting in accidents, damage, injury or illness to myself and to my property, including the horse(s) which I may ride, own or lease.

I understand and agree that the management of Kealani Farm has the right to cancel this activity; to refuse any entry or application; to require and enforce the wearing of safety or other attire and the conduct of riders, horses, and visitors; and to prohibit, stop or control any action during the activity deemed by the management to be improper or unsafe.
