Pub at Dressage at Devon (Mike Broomall, Robin Ross): Darcy and Mike met with Lori Kaminski and Anne Moss to discuss. DVCTA will staff the pub Tues. to Sunday. Must buy booze from DAD vendors. Need to get a serving license to do food but Mike says it does not look difficult.

Annual Dinner (Lisa Leana): The total for the February banquet was \$4,833.60 plus the band \$300.00 = \$5,133.60. Ticket sales less the paypal fees was \$4,803.84. So we almost broke even – spent just \$329.76 on an event that was well-attended and enjoyed by the membership – definitely part of our job as DVCTA! Feedback was that the food was good, people liked how the banquet was run and the silent auction was the best in recent memory for some people, citing the variety and volume of items.

Annual Auction (Linda Drejza, Kelly Barry, Joanne Mohr, Rita Lowry): Total take on the silent auction and 50/50 raffle:

Paypal: \$1,645.00 Checks \$1,662.00 Cash: \$919.00 For a total of \$4,226.00 Plus \$306 (total) from the raffle (the \$153 was donated back) Totaling \$4,532.00

For comparison, the past 2 were online auctions. 2021 had 52 items and raised \$3,310. 2022 had 56 items and raised \$4,377. The auction committee had a short time frame due to the passing of Lisa Knox to pull off the auction and did a fantastic job. Next year we can start earlier and have even more options.
